INSTRUCTION FOR CANDIDATES

Candidates are advised to verify their Name / Profile ID in the list and read the **instructions** given below carefully.

1. Based on the information furnished by you in your application form, you have been short-listed for appearing in Written Test for selection to the above-mentioned post.
2. You are advised to appear for the Written Test on the date, time and venue mentioned above. Please reach at the Test Centre **30 minutes prior** to the scheduled time. Candidates coming late for the written Exam shall not be allowed to sit in the Written Exam after the commencement of the exam.
3. Further, you need to come for Written Test and subsequent selection process only in case you meet the eligibility criteria for the post. Candidates are advised to carefully ensure that they fulfil all the eligibility conditions (age, educational qualification, stream, category, experience and other criteria) as prescribed in the original notification. In any stage of selection process if it is found that you are not meeting the eligibility criteria for the post, your candidature shall be liable for disqualification.

4. Your candidature for this test is provisional and is subject to your fulfilling the educational and other eligibility criteria prescribed for the post. Non-fulfilment of the prescribed requirements, if found later on, at any stage of selection or after that, will render your candidature liable for disqualification unilaterally without any notice.
5. Selection process shall consist of Written Test, Document Verification and Skill Test/Interview. Candidates have to qualify each stage of selection process to be eligible for short-listing to next stage of selection process.
6. The Written Test shall be of Objective Type – Multiple Choice Questions (MCQ) consisting of 4 options with one correct option. Candidate has to choose the correct option. There shall be total 50 objective type questions with 1 mark each from the discipline of Engineering level. No negative marks for the wrong answer.
7. Candidates must bring One valid Photo ID proof in original (Aadhaar / PAN / Passport / Driving License/Voters ID) and Ball Pen (blue or black), for writing the examination. Failure to produce the above documents will result in denial of entry to the examination hall.
8. Document Verification- Only candidates who qualify in the Preliminary Examination will only be called for Document Verification. Non-production of required documents shall lead to disqualification.
9. Right to Reject-The Organization reserves the absolute right to reject or disqualify any candidate at any stage of the selection process if:
 - The candidate is found ineligible;
 - Any information furnished is false, incorrect, or misleading;
 - The candidate is involved in malpractice or misconduct.
10. Code of Conduct During Examination-Mobile phones, smart watches, calculators, Bluetooth devices, or any electronic gadgets are strictly prohibited inside the examination hall. Any act of indiscipline, impersonation, or use of unfair means will result in immediate disqualification and may attract further legal action.
11. No TA/DA- No Traveling Allowance (TA) or Dearness Allowance (DA) will be paid for attending the Preliminary Examination or any subsequent stages of the selection process.
